

# Notice of Election on Tax Levy in Excess of the Ten Mill Limitation

Notice is hereby given that in pursuance of a Resolution of the  
Board of Trustees of the Township of Union  
Champaign County, Ohio passed on the 20th day of  
April, 2009 there will be submitted to a vote of the people of said  
subdivision at a General ELECTION  
(General, Primary or Special)  
to be held in the Township of Union  
Ohio, at the regular places of voting therein, on the 3rd day of  
November, 2009 the question of levying a tax, in excess of the ten mill  
limitation, for the benefit of Union Township (exclusive of the Village of Mutual)  
(Name of Subdivision)

for the purpose of **GENERAL CONSTRUCTION, RECONSTRUCTION, RESURFACING AND REPAIR OF ROADS AND BRIDGES.**

Said tax being: <sup>2</sup> a replacement of an existing levy of 2 mills

at a rate not exceeding 2 mills for each one dollar of valuation, which amounts  
to \$0.20 for each one hundred dollars of valuation,  
(Rate expressed in dollars and cents)  
for five years, commencing in 2010, first due in calendar year 2011.  
(Number of years the levy is to run, life of indebtedness, or "continuing period of time")
