

# PROCLAMATION

## NOTICE OF ELECTION ON TUESDAY, MAY 3, 2011

### **Primary Election in the City of Wilmington and the Village of Blanchester and Special Election in the Village of Port William**

The Board of Elections of Clinton County, Ohio issues this Proclamation and Notice of Election: A Primary/Special Election will be held on Tuesday, the 3rd of May, 2011 (the first Tuesday after the first Monday in May) at the usual places of holding elections in select precincts throughout said County or at such places as the Board may designate, for the purpose of choosing the Republican Party nominees for the following offices in the *City of Wilmington*: Mayor; President of Council; Auditor; Director of Law; Three (3) Members of Council At Large; Member of Council First Ward; Member of Council Second Ward; Member of Council Third Ward; and Member of Council Fourth Ward. In the *Village of Blanchester* for the purpose of choosing the following Republican Party nominees for the offices of: Mayor; One (1) Member of Council; and Two (2) Members of the Board of Trustees of Public Affairs. In addition, to determine the following Question and Issue: in the *Village of Port William* a Proposed Tax Levy for Current Expenses, Additional 3 mills (\$0.30 for each one hundred dollars of valuation), for 5 years, commencing in 2011, first due in calendar year 2012.
