VOTING EQUIPMENT ALLOCATION PLAN

Acquisition & Inventory of Voting Equipment

1. Clinton County (Clinton) owns 39 M-100's for its 38 precincts.
2. Typically three (3) or four (4) of our smaller precincts share one M-100. For November 2009 six (6) precincts will share an M-100 (see Exhibit A):
  - Adams A & Adams B
  - Chester A & Chester B
  - New Vienna and Green
  - Midland and Jefferson
  - Port William and Liberty
  - Vernon A & Vernon B
3. Clinton County has twenty (20) polling locations
4. Clinton County owns twenty-five (25) Auto Marks.
5. Clinton County owns 262 votamatics which are used as voting booths.
6. Clinton County owns one (1) Ballot on Demand system to print ballots when the demand exceeds the supply.
7. Our Unity system is comprised of two PC's and one printer.
8. The Clinton County Board of Elections plans to use all of its equipment on Election Day.
9. Clinton County purchased two M-100's prior to the November 2007 general election. Clinton County, meaning the board and the county, do not have the funds this year to purchase additional M-100's.

Allocation and Distribution of Voting Equipment

1. The voting booths will be allocated based on one booth for approximately every 100 voters in the precinct.
2. Each precinct except the following will have one (1) M-100 scanner. This is necessary to have enough scanners for absentee tabulation and back-ups in case of equipment problems. This consolidation is based on voter turnout trends and the fact these precincts are in the same buildings.
  - Adams A & Adams B
  - Chester A & Chester B
  - New Vienna and Green
  - Midland and Jefferson
  - Port William and Liberty
  - Vernon A & Vernon B
3. A total of three (3) M-100's will be kept at the board office for backup.
4. Four (4) M-100 scanners will be used in the office for absentee tabulation. This means each scanner will have to count absentee ballots for 9 -10 precincts.

5. One (1) AutoMark will be assigned to each poll, except the Clinton County Fairgrounds Expo Center will have two (2) AutoMarks for its six (6) precincts.
6. Four (4) AutoMarks will be available for backup.
7. As of September 14, 2009 Clinton County has 22,170 registered voters. A list of precincts (Exhibit A-1) and the number of registered voters in each precinct (Exhibit A-2) are attached.
8. Exhibit B outlines the voter turnout in each precinct from the November 2007 general election.
9. The Clinton County Board of Elections followed the SOS guidelines for allocating voting equipment.
