

**PROCLAMATION  
NOTICE OF GENERAL ELECTION**

The Board of Elections of Clinton County, Ohio issues this Proclamation and Notice of Election:

**A GENERAL ELECTION WILL BE HELD ON TUESDAY, the 3<sup>rd</sup> of NOVEMBER 2009** (the first Tuesday after the first Monday in November) at the usual places of holding elections in each and every precinct throughout said County or at such places as the Board may designate, for the purpose of choosing the following: Municipal Offices for City and Village Councils, Treasurer, Board of Public Affairs; Municipal Court Judge; Township Trustees; Members of Board of Education; and determining the following Questions and Issues:
