Sealed bids will be received by the Clark County Board of Elections, 3130 East Main St., P.O. Box 1766, Springfield, Ohio 45501, UNTIL TUESDAY, NOVEMBER 22, 2011 AT 2:00 p.m. for the printing of ballots for the 2012 Clark County Primary Election, pursuant to the request for proposal specifications. PLEASE NOTE: BIDS DELIVERED/ RECEIVED AFTER THE SUBMITTAL TIME (EXACTLY 2:00 P.M. ON THE BOARD OF ELECTIONS CLOCK) WILL NOT BE ACCEPTED. Each bid shall contain the full name and address of each person or company submitting the bid. All bids must be submitted to the Clark County Board of Elections, 3130 East Main St., P.O. Box 1766, Springfield, Ohio NO LATER THAN TUESDAY, NOVEMBER 22, 2011 AT 2:00 P.M. Bids will be opened by the Director in public session on Tuesday, November 22, 2011 at approximately 2:00 p.m. at the Board of Elections, 3130 East Main St., Springfield, Ohio. Bids shall be clearly marked on the outside of the envelope in the lower left hand corner as "Bid Enclosed". The name and address of the bidder must also appear on the outside of the envelope.

Each bid must be accompanied by two sureties, or a sureties company satisfactory to the Board, in a sum double the amount of the bid, conditioned upon the faithful performance of the contract for such printing as is awarded and for the payment as damages by such bidder to the Board of any excess of cost over the bid which may be obliged to pay for such work by reason of the failure of the bidder to complete the contract. FAILURE TO SUBMIT A PROPER BOND WILL AUTOMATICALLY INVALIDATE THE BID. Bid guaranties of unsuccessful bidders will be returned following award of bid.

Bidders must submit the following: Bid bond, Non-Discrimination Provision, Non-Collusion Affidavit, Personal Property Tax Statement, and an Affidavit of Compliance with ORC 3517.13. The successful bidder must also meet the County's insurance requirements (the list of requirements are included in the request for proposal package). PLEASE NOTE: the County is exempt from all Federal, State, Local and/or Excise Taxes.
