

**PROCLAMATION
NOTICE OF GENERAL ELECTION**

The Board of Elections of Clinton County, Ohio issues this Proclamation and Notice of Election:

A GENERAL ELECTION WILL BE HELD ON TUESDAY, the 4TH of NOVEMBER 2008 (the first Tuesday after the first Monday in November) at the usual places of holding elections in each and every precinct throughout said County or at such places as the Board may designate, for the purpose of choosing the following: President and Vice-President; Ohio Attorney General; United States Representative to Congress 3rd District; Justice of the Supreme Court (full term commencing 1/1/09); Justice of the Supreme Court (full term commencing 1/2/09); Judge of the Court of Appeals 12th District (full term commencing 1/1/09); Judge of the Court of Appeals 12th District (full term commencing 2/9/09); State Representative 86th District; Judge of the Court of Common Pleas Probate & Juvenile Divisions (full term commencing 2/9/09); County Commissioner (full term commencing 1/2/09); County Commissioner (full term commencing 1/3/09) Prosecuting Attorney; Clerk of the Court of Common Pleas; County Sheriff; County Recorder; County Treasurer; County Engineer; County Coroner; Member of State Board of Education 10th District; and determining the following Questions and Issues:

Issue 1	To provide for earlier filing deadlines for statewide ballot issues
Issue 2	To authorize the State to issue bonds to continue the Clean Ohio Program for Environmental Revitalization & Conservation
Issue 3	To amend the Constitution to protect private property rights in ground water, lakes & other watercourses
Issue 4	Withdrawn by petitioner's committee on September 4, 2008
Issue 5	Referendum on legislation making changes to check cashing lending, sometimes known as "payday lending," fees, interest rate and practices
Issue 6	To amend the Ohio Constitution by initiative petition for a casino near Wilmington in southwest Ohio & distribute to all Ohio counties a tax on the casino
