

March 2012 Voting Equipment Report

In December 2005, the Fayette County Board of Elections purchased 27 optical M-100 scanners with ballot bins and 23 AutoMark marking devices from ES&S. In Jan. 2010, 2 additional M-100's were purchased.

The Fayette County Board of Elections will utilize 100% of their ES&S optical scanners and will distribute one Automark to each of the polling locations. Four precincts will be sharing M-100's as noted below. These assignments are deviations from the recommendations of the SOS. The Board decision was made after analyzing the use of the Automark from previous elections and taking into consideration the number of registered voters per precinct in regard to the shared M-100's.

In keeping with Directive 2008-64, the BOE will maintain 7 optical scanners at the board office to deploy to any precinct or polling location experiencing long lines or machine malfunction.
